### **Gap Analysis**

Depending on the clients Transaction and Code Set needs, Softima has partnered with Claredi, which offers Testing tools necessary to qualify and thoroughly test the Transaction Sets. - Customizable features to convert back-end legacy data to HIPAA Transaction sets
- Integration of External Code Sets by using Rules Engine
- Configurable connectivity with Trading Partners based on Transaction sets
- Seamless Integration to the back-end systems
- Fully Integrated Security using X.509 digital certificates, PKCS #7 digital signatures, RSA SSL and Access Control Lists
- Connectivity Support for HTTP(s), FTP and SMTP
- Functional Acknowledgement using EDI 997 as a Response and/or failure through E-mail Alerts
- Exception handling
- Manage complete end-to-end transaction tracking

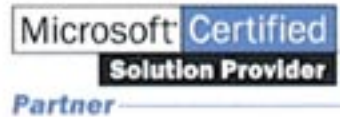
